WHAT DOES BANORTE VENTURES LTD. (“BINVESTING”) DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect, and share depend on the product or service you have with us. This information can include:

- Social Security Number and Investment Experience
- Income and Risk Tolerance
- Assets and Account Transactions

How?

All financial companies need to share customer’s personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customer’s personal information; the reasons **Banorte Ventures LTD (BINvesting)** chooses to share; and whether you can limit this sharing.

What we do

How does BInvesting protect my information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does BInvesting collect my personal information?

We collect your personal information, for example, when you

- Open an account or give us your contact information
- Make a wire transfer or show your government ID
- Enter into an investment advisory contract

We also collect your personal information from others, such as affiliates or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

What happens when I limit sharing for an account, I hold jointly with someone else?

Your choices will apply to everyone on your account.

Definitions

Affiliates

Companies located in the United States related by common ownership or control. They can be financial and non-financial companies.

- Banorte Securities International Ltd.
- Banorte Asset Management, Inc.
- Banorte Securities Holding International Inc.
- Banorte Enterprises Ltd.

Nonaffiliates

Companies not related by common ownership or control. They can be financial and non-financial companies.

- *BInvesting does not share with non-affiliated financial companies for marketing purposes.*

Joint Marketing

A formal agreement between non-affiliated financial companies that together market financial products or services to you.

- *BInvesting does not engage in joint marketing agreements with nonaffiliated financial companies.*

Other Important Information

This notice applies only to affiliates of Banorte Ventures, Ltd. located in the United States.

For California Residents

Under CCPA (California Consumer Privacy Act. 2018), California residents have the right to know the categories and pieces of information we have collected, disclosed, or used in the past twelve months and may have the following rights:

Access	You may have the right to access your personal data collected by the Firm.
Verification	We may require you to verify your identity before you can submit a rights request. If we cannot confirm your identity, we may refuse your request.
Right to Know	You have the right to know the categories of personal information, sources and third parties processing your personal information.
Request a copy of your personal information	You may request a copy of your personal information collected by the Firm.
Correct your personal information	You can request that we edit or correct your personal information anytime.
Deletion	Under certain circumstances, you may have the right to request that we delete the personal information you have provided.
Limit information sharing	You have the right to limit the sharing of your personal information.
Non-discrimination	You will not be discriminated against because of the exercise of any of your California privacy rights.
